The council of the Energy Regulatory Office will decide on the objection.

According to section 152, paragraph 5 of the Czech Administrative Code in conjunction with section 85, paragraph 1 of the Czech Administrative Code, any objection lodged against this decision has a suspensory effect. The term for the lodging of an objection commences on the calendar day which follows the day on which you were serviced with the decision, but no later than after the end of the tenth day as from the day on which the decision was deposited for collection after efforts to deliver it have proven fruitless.
